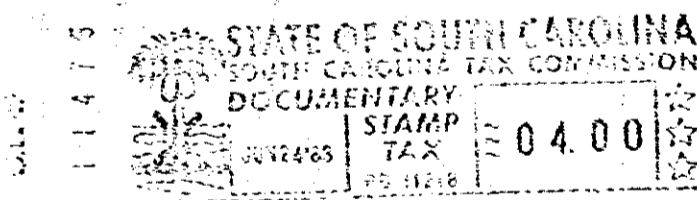
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville, City of Greenville**, being known and designated as **Lot No. 13 of Block O of a subdivision of property of O. P. Mills**, as shown on plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book F, Page 299 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Kim Street at the joint corner of Lots Nos. 13 and 12; running thence along the northern side of Kim Street N. 89-51 W., 70.5 feet to an iron pin at the corner of Lot No. 14; thence along the line of that lot N. 6-16 E., 181 feet to an iron pin at the rear corner of Lots Nos. 13, 14, 15 and 16; thence N. 70-39 E., 63 feet to an iron pin at the rear corner of Lots Nos. 12 and 13; thence S. 2-36 W., 201.2 feet to the beginning corner.

This is the same property conveyed to the mortgagors by deed of Thomas C. Edwards and Mary M. Edwards recorded in the R.M.C. Office for Greenville County on June 2, 1978, in Deed Book 1080, Page 368.

This mortgage is junior in lien to that certain mortgage executed in favor of First Federal Savings and Loan Association in the original amount of \$40,000.00 recorded in the R.M.C. Office for Greenville County on June 2, 1978, in R. E. Mortgage Book 1434, Page 137.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
