"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lots Nos. 1 and 2 Block D, of a subdivision known as BUENA VISTA according to a survey prepared by W. W. Willis, Engineer, dated August 4, 1949, recorded in the RMC Office for Greenville County in Plat Book W at Page 11 and having such metes and bounds as shown thereon, reference to said plat being made for a more complete description.
