MORTGAGE

THIS MORTGAGE is made this 23rd day of June, 1983, between the Mortgagor, Mae G. Peigler

, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

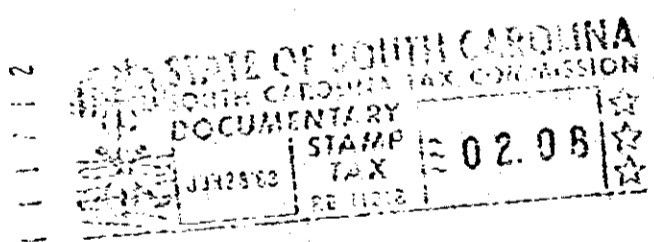
WHEREAS, Borrower is indebted to Lender in the principal sum of \$5,131.08 (Five thousand One hundred-thirty-one and 08/100) Dollars, which indebtedness is evidenced by Borrower's note dated June 23rd 1983, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on June 30, 1988

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina.

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, and being known and designated as Lots nos. 12 and 13 on the eastern side of Shamrock Circle on a plat of Shamrock Acres of record in the RMC Office for Greenville County in Plat Book YY at Page 43 reference to which is craved for a metes and bounds description thereof.

This being the same property conveyed to the mortgagor by deed of N. R. Neal and recorded in the RMC Office for Greenville County on August 4, 1969 in Deed Book 873 at Page 197.

This is a second mortgage and is Junior in Lien to that mortgage executed by Mae G. Peigler to Collateral Investment Company which mortgage is recorded in the RMC Office for Greenville County on August 4, 1969 in Book 1133 at Page 153. Subsequently assigned to Federal National Mortgage Association on October 7, 1969 in Book 1139 at Page 51.

Borrower covenants that Borrower is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
