MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being on the northern side of Forestdale Drive in Chick Springs Township, known and designated as Lot No. 3 on a plat of Forestdale Heights, made by R. K. Campbell, Engineer, December, 1956, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book KK at Page 199 and having such metes and bounds as shown thereon.
