MORTGAGE OF REAL ESTATE
TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, SHIRLEY C. BUCHANAN

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northerly side of Merrifield Court and being known and identified as Lot No. 105 according to a plat entitled "Final Plat Revised, Map No. 1, Foxcroft, Section II", which plat is recorded in the RMC Office for Greenville County, S.C., in Plat Book 4-N at Pages 36 and 37, and having such metes and bounds as shown thereon.

This being the same property conveyed to the Mortgagor and Jack O. Buchanan by deed of Thomas E. Talley, Inc. recorded June 5, 1973, in the RMC Office for Greenville County, S.C., in Deed Book 976 at Page 137. Jack O. Buchanan conveyed his one-half interest in said property to the Mortgagor by deed recorded April 25, 1977, in the RMC Office for Greenville County, S.C., in Deed Book 1055 at Page 253.
