Whereas, I the said John W. McCuen

in and by my certain promissory

note in writing, of even date with

these presents, am well and truly indebted to Southern Bank and Trust

Company of Williamston, South Carolina

in the full and just sum of Seventeen Thousand Two Hundred Forty-Four and 92/100

(\$17,244.92) Dollars to be paid in One Hundred Twenty (120) equal installments in the sum of Two Hundred Sixty-Three and 97/100 (\$263.97) Dollars each, beginning August 15, 1983 and a like installment being due and payable on the 15th day of each and every calendar month thereafter until paid in full.

with interest thereon from date business prime plus 3% at the rate of XXXXX per cent, per annum to be computed and paid monthly
