MORTGAGE

THIS MORTGAGE is made this 17th day of June, 1983, between the Mortgagor, Robert M. Poland and Linda N. Poland, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of \$23,443.40 (~~Twenty-three thousand four hundred forty-three and 40/100~~) Dollars, which indebtedness is evidenced by Borrower's note dated June 17, 1983, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on June 30, 1993;

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of GREENVILLE, State of South Carolina.

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, known and designated as Lot no. 151 on plat of Pebblecreek Phase One recorded in the RMC Office of Greenville County in Plat Book 5D on Page 3.

This being the same property conveyed to the mortgagor by deed of First Federal Savings and Loan Association and recorded in the RMC Office for Greenville County on March 1, 1979 in Deed Book 1097 at Page 626.

This is a second mortgage and is Junior in Lien to that mortgage executed by Robert M. and Linda N. Poland to First Federal which mortgage is recorded in the RMC Office for Greenville County on March 1, 1979 in Book 1458 at Page 596.
