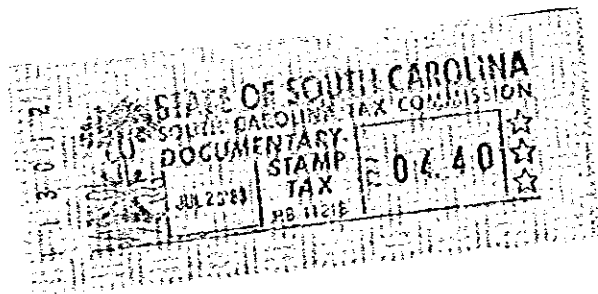
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the Town of Simpsonville, and being shown as Lot No. 135 on plat of Woodside Mills, Simpsonville, S.C., made by Piedmont Engineering Service, Greenville, S.C., February 1953, and recorded in the RMC Office for Greenville County in Plat Book GG, at page 5.

This is the same property inherited by Johnny Michael Land from Willie Dupree Nelson Mostella, which Estate File is recorded in Apartment 1711, File 19, and a one-half interest conveyed to Annie M. Land by Johnny Michael Land by deed to be recorded herewith.
