MORTGAGE

THIS MORTGAGE is made this 18th day of July, 1983, between the Mortgagor, Michael L. Boyles and Gloria G. Boyles, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Twenty Five Thousand Eight Hundred Fifty Three and 80/100 Dollars, which indebtedness is evidenced by Borrower's note dated July 18, 1983, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on July 30, 1993;

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina.

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, known and designated as Lot 10 Ferncreek Subdivision, shown on plat made by Dalton & Neves, Engineers, dated November, 1973 and recorded in the RMC Office for Greenville County in plat Book 5 D at Page 28. Reference to said plat is hereby craved for a metes and bounds description.

This is the same property conveyed to the Mortgagors herein by deed of William E. Smith, Limited, a Partnership, dated September 17, 1975, and recorded in the RMC Office for Greenville County on September 18, 1975 in Deed Book 1024 at Page 390.

This mortgage is junior in lien to that mortgage given by the Mortgagor herein to South Carolina National Bank dated September 17, 1975, and recorded in the RMC Office for Greenville County on September 18, 1975, in Mortgage Book 1349 at Page 34.
