- (A) Mortgage—This document, which is dated July 22, 19 83, will be called the "Mortgage".
- (B) Mortgagor—Stanley M. Brown will sometimes be called "Mortgagor" and sometimes simply "I." "Me", "my", "mine", "myself", and "us" refer to the Mortgagor.
- (C) Lender—The South Carolina National Bank will be called "Lender" and sometimes simply "you". "Your" and "yours" refer to Lender. Lender is a national banking association which was formed and which exists under the laws of the United States of America.

- (D) Note—The note, note agreement, or loan agreement signed by Stanley M. Brown and dated July 22, 1983, will be called the "Note". The Note shows that I have promised to pay Lender

If this box is checked, finance charges or interest under the Note will be deferred, accrued, or capitalized.

- (E) Property—The property that is described below in the section entitled "Description Of The Property" will be called the "Property".

My Transfer To You Of Rights In The Property

On this date, because you loaned me the money for which I gave you the Note, I mortgage, grant and convey the Property to you, your successors and assigns, subject to the terms of this Mortgage. This means that by signing this Mortgage, I am giving you those rights that are stated in this Mortgage and also those rights that the law gives to lenders who hold mortgages on real property. I am giving you these rights to protect you from possible losses that might result if I fail to:

- (A) Pay all the amounts that I owe you as stated in the Note and any future advances made under Paragraph 17 of this Mortgage.
- (B) Pay, with interest or finance charges, any amounts that you spend under this Mortgage to protect the value of the Property and your rights in the Property.
- (C) Keep all of my other promises and agreements under the Note and/or this Mortgage.

This Mortgage secures any renewals, extensions, and/or modifications of the Note.

Description Of The Property

- (A) The Property which I mortgage, grant, and convey to you, your successors and assigns, is located in Greenville County and has the following legal description:

ALL those lots of land numbered 82,89,90,153-156 inclusive,162-173 inclusive,178-187 inclusive, and 194-200 inclusive, as shown and designated on a plat of a subdivision formerly known as The Village, Section II, and now known as The Shoals, said plat being recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4-R, at page 53.

This being a portion of the property conveyed to the Mortgagor herein by deed of The Fortis Corporation dated September 1, 1981, and recorded in the RMC Office for Greenville, South Carolina in Deed Book 1154 at page 684.

The Property also includes the following:

- (B) All buildings and other improvements that are located on the property described in paragraph (A) of this section;
- (C) All rights in other property I have as owner of the property described in paragraph (A) of this section. These rights are known as "easements, rights and appurtenances attached to the property";
