REAL PROPERTY AGREEMENT

In consideration of such loans and indebtedness as shall be made by or become due to American Federal Savings and Loan Association of Greenville, S. C. The affidavit of any officer or department manager of Association showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
