THIS MORTGAGE is made this 29th day of July, 1983, between the Mortgagor, Gary H. Morton and Sarah L. Morton, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS Borrower is indebted to Lender in the principal sum of Thirty Seven Thousand and No/100 (\$37,000.00) Dollars, which indebtedness is evidenced by Borrower's note dated July 29, 1983, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on August 1, 1983.....;

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina.

ALL that lot of land with improvements thereon lying on the Southwestern side of Oak Drive in Greenville County, South Carolina, being shown and designated as Lot No. 7 on a plat of the property of Henry C. Harding Builders, Inc. made by Campbell & Clarkson, Surveyors, dated July 12, 1967 and recorded in the RMC Office for Greenville County, S. C. in Plat Book PPP at Page 95 and having metes and bounds as shown thereon.

This being the same property acquired by the mortgagors by deed to be recorded herewith.
