Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto ALLIANCE MORTGAGE COMPANY

organized and existing under the laws of the State of Florida, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Twenty Six Thousand One Hundred Fifty and No/100 Dollars (\$ 26,150.00).

with interest from date at the rate of twelve and one-half per centum (12.5 %) per annum until paid, said principal and interest being payable at the office of Alliance Mortgage Company in Jacksonville, Florida 32252 P.O. Box 4130 or at such other place as the holder of the note may designate in writing, in monthly installments of Two Hundred Seventy Nine Dollars (\$ 279.28) and 28/100 commencing on the first day of September, 19 83, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of August, 2013

All that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, on the southwestern side of Taber Street and being known and designated as Lot No. 5 on plat of Property of James M. Bruce and Furman C. Smith and others recorded in the R.M.C. Office for Greenville County in Plat Book T, Page 173 and having, according to a more recent survey prepared by Freeland and Associates entitled Property of Timothy P. Sowles and Jane E. Sowles, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Taber Street at the joint front corner of Lots Nos. 5 and 6 and running thence along said Street N. 23-20 W., 25 feet to an iron pin; thence continuing along said Street N. 8-25 W., 29.4 feet to an iron pin; thence N. 75-0 W., 49.2 feet to an iron pin; thence S. 57-41 W., 93.2 feet to an iron pin; thence S. 23-20 E., 43.1 feet to an iron pin; thence along the joint line of Lots Nos. 5 and 6 N. 66-40 E., 125.6 feet to the point of beginning.
