To secure payment of a note which I signed today promising to pay you the above total of payments and to secure all my other and future obligations to you, the Maximum Outstanding at any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of **Greenville**

All that certain piece, parcel or lot of land situate; lying and being in the County of Greenville, State of South Carolina, on the southern side of S.C., Rd, 450, being the eastern one-acre lot of land as shown on a plat of property of Ramsey Lollis, prepared by C. O. Riddle R. L. S., on May 15, 1968, and having according thereto the following courses and distances to-wit:

If I pay the note secured by this mortgage according to its terms this mortgage will become null and void.

You may pay any such tax, lien, assessment, obligation, encumbrance or other charge or purchase such insurance in your own name, if I fail to do so. If I do not eliminate the default in the manner stated in the notice, or if I eliminate the default after you send the notice but default on a future payment by failing to pay on schedule, or if my ability to repay my loan or the condition, value or protection of your rights in the collateral securing my loan is significantly impaired, then the full amount I owe, less any charges which you have not yet earned, will become due, if you desire, without your advising me.

I will pay all expenses you incur in enforcing any security interest, including reasonable attorney's fees as permitted by law.

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

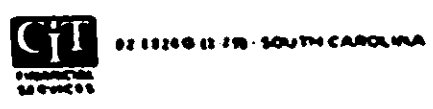
Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.
