NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, the Mortgagee's heirs, successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeast side of South Estate Drive in Gantt Township, near the City of Greenville, being shown as Lot 65 on plat of Crestwood, Inc., made by J. C. Hill, Surveyor, February 28, 1949, said plat being recorded in the RMC Office for Greenville County, S. C. in Plat Book S at Page 189, said lot fronting 70 feet along the northeast side of South Estate Drive, and running back on the southeast side a depth of 170.7 feet, and on the northwest side a depth of 164.2 feet, and being 78 feet across the rear.

This being the same property acquired by the Mortgagors by deed of Donald E. Johnson, as Administrator of Veterans' Affairs recorded in the RMC Office for Greenville County in Deed Book 877 at Page 313 on October 9, 1969.
