NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwestern side of Tammy Trail, being shown as Lot 8 on a plat of Cherokee Mobile Homes Estate, dated November, 1973, prepared by Dalton & Neves Company, recorded in Plat Book 5-D at Page 27 in the RMC Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Tammy Trail at the joint front corner of Lot 7 and Lot 8 and running thence with Lot 7 S. 33-22 W. 215.7 feet to an iron pin at the joint rear corner of Lot 7 and Lot 8; thence N. 15-37 W. 327.9 feet to an iron pin on the southwestern side of Tammy Trail; thence with said Trail S. 56-47 E. 247.4 feet to the point of beginning.
