THE NOTE CONTAINS PROVISIONS ALLOWING FOR CHANGES IN THE INTEREST RATE AND MONTHLY PAYMENTS.

Beginning on the date of this Note, I will owe interest at a yearly rate of 13.00%. The rate of interest I will owe will change on the first day of April , 19.84, and on that day every 6th month thereafter. Each date on which my rate of interest could change is called an "Interest Change Date." My new rate of interest will become effective on each Interest Change Date.
