THIS MORTGAGE is made this 28th day of September, 19 83
between the Mortgagor MARGARET E. SCOTT
(herein "Borrower"), and the Mortgagee, ALLIANCE MORTGAGE COMPANY,
a corporation organized and existing under the laws of FLORIDA,
whose address is P. O. Box 2139, Jacksonville, Florida 32232
(herein "Lender").

Thirty-six thousand five hundred and no/100-----
WHEREAS, Borrower is indebted to Lender in the principal sum of (\$36,500.00)--- Dollars,
which indebtedness is evidenced by Borrower's Note date September 28, 1983 (herein "Note"),
providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner
paid, due and payable on October 1, 20 13.

TO SECURE to Lender: (a) the repayment of the indebtedness evidenced by the Note with interest thereon,
the payment of all other sums with interest thereon, advanced in accordance herewith to protect the security of
this Mortgage, and the performance of the covenants and agreements of Borrower herein contained; and (b) the
repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21
hereof (herein "Future Advances"), Borrower does hereby mortgage, grant, and convey to Lender and Lender's
successors and assigns the following described property located in the County of Greenville,
State of South Carolina:

State of South Carolina, County of Greenville, being known and designated
as Unit Number 301 Phase II of SUMMER WOODS HORIZONTAL PROPERTY REGIME as
is more fully described in MASTER DEED dated September 16, 1981, and re-
corded in the RMC Office for Greenville County, South Carolina in Deed
Book 1155 at Page 564 through 634 inclusive, CORRECTION TO MASTER DEED
recorded in Deed Book 1156 at Page 454, and AMENDMENT TO MASTER DEED
recorded August 12, 1982, in Deed Book 1172 at Page 62, and AMENDMENT TO
MASTER DEED recorded January 6, 1983 in Deed Book 1180 at Page 410 and
AMENDMENT TO MASTER DEED recorded May 27, 1983 in Deed Book 1188 at Page
981 and plat of SUMMER WOODS PHASES I & II prepared by Kermit T. Gould,
dated September 10, 1981, revised December 23, 1982 and May 12, 1983 and
recorded in Plat Book 9Q at Page 30.
