"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville, Greenville Township, being parts of lots 19 and 20 in a Subdivision known as Hillcrest Circle as shown on plat recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book H, Page 129, and further described as follows:**

**BEGINNING at a point on the west side of Hillcrest Circle at the approximate center of Lot 20 and running thence with the west side of Hillcrest Circle N. 12-45 E., 75 feet to a point; thence N. 72-30 W., 158.6 feet to a point; thence S. 26-40 W., 75.8 feet to a point; thence S. 72-30 E., 178 feet to the point of beginning.**
