MORTGAGE OF REAL ESTATE
TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, PATRICK J. RODRIGUE AND SUSAN L. RODRIGUE

(hereinafter referred to as Mortgagor) is well and truly indebted unto

COMMUNITY BANK

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Sixty Six Thousand Three Hundred Twenty Seven and 03/100---

----- Dollars (\$ 66,327.03) due and payable
in accordance with terms of note of even date herewith

with interest thereon from date at the rate of prime + 2% per centum per annum, to be paid: monthly

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, as being shown on a plat entitled Survey for Patrick J. Rodrigue and Susan L. Rodrigue made by Carolina Surveying Company on January 3, 1978, and being recorded in the Greenville County R.M.C. Office in Plat Book 6L, Page 39 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Donkle Road, at the corner of the property shown as Commodity Warehouse Co., Inc., and running thence N. 37-56 E., 260.3 feet to an old iron pin; thence along the common line of the Katherine C. Ross property N. 83-80 E., 383 feet to an iron pin; thence running along the common line of the Rodrigue Mfg. Co., Inc. property S. 37-56 W., 528.3 feet to an iron pin on Donkle Road; thence along the eastern side of Donkle Road N. 52-05 W., 273.5 feet to an old iron pin, being the point of beginning.
