in monthly installments of Seventy-Three and 76/100 (\$73.76) Dollars each beginning January 15, 1984 and continuing on the 15th day of each month until paid in full

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

Greenville, being more particularly described as Lot No. 402, Section 2, as shown on a plat entitled Subdivision for Abney Mills, Brandon Plant, which plat is recorded in the RMC Office for Greenville County in Plat Book QQ, at pages 56-59. According to said plat, the within described lot is also known as 2 Wilson Street (McArthur Street) and fronts thereon 100 feet.
