MORTGAGE

THIS MORTGAGE is made this 7th day of September, 1983, between the Mortgagor, Stephen L. Yearick (herein "Borrower"), and the Mortgagee, Alliance Mortgage Company, a corporation organized and existing under the laws of the State of Florida, whose address is P. O. Box 2259, Jacksonville, Florida 32232 (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of One Hundred Forty-Four Thousand Five Hundred and No/100 Dollars, which indebtedness is evidenced by Borrower's note dated September 7, 1983 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on October 1, 2013

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the southwestern side of Club Forest Lane and being shown and designated as Lot No. 10 and a portion of Lot No. 9 on plat of CLUB FOREST Subdivision recorded in the RMC Office for Greenville County in Plat Book 9-F at Page 15 and being shown on a more recent plat entitled "Property of Stephen L. Yearick", prepared by Freeland & Associates, dated September 7, 1983, and recorded in the RMC Office for Greenville County in Plat Book 9-Z at Page 55, and having such metes and bounds as shown on the more recent plat, reference to which is hereby made for a more complete description.

THIS is the same property as that conveyed to the Mortgagor herein by deed from Builder Service Group, Inc. recorded in the RMC Office for Greenville County of even date herewith.
