THIS MORTGAGE is made this 24 day of October, 19 83  
between the Mortgagor Clifton O. Zimmerman  
(herein "Borrower"), and the Mortgagee, Alliance Mortgage Company,  
a corporation organized and existing under the laws of Florida,  
whose address is P.O. Box 2139, Jacksonville, Florida 32232  
(herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of \$26,600.00 Dollars,  
which indebtedness is evidenced by Borrower's Note date October 24, 1983 (herein "Note"),  
providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner  
paid, due and payable on November 1, 20 13.
