This Mortgage is made this 7th day of November, 19 83 between Mortgagor Smith & Steele Builders, Inc. a corporation organized and existing under and by virtue of the laws of the State of South Carolina (herein "Borrower"), and the Mortgagee, The South Carolina National Bank, a corporation organized and existing under the laws of the United States of America whose address is Post Office Box 969, Greenville, S.C. (herein "Lender").
