NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot 9 on plat of Abney Mills, Poinsett Plant, which plat is recorded in the RMC Office for Greenville County in Plat Book QQ, at page 51, reference to said plat being craved for a more complete description thereof.

This is the same property conveyed unto Lucy Carithers Stevens Butler and T. B. Butler by deed of William Pickney Hammett recorded in Deed Book 983, at page 500, on September 10, 1973. Thomas B. Butler died testate on September 13, 1976, leaving all his property to his wife, the Mortgagor herein, see Apartment 1440, File 11, Probate Court records.
