"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

ALL that certain piece, parcel or tract of land with the buildings and improvements thereon lying and being on the southeasterly side of Motor Boat Club Road, near the City of Greenville, South Carolina, containing twelve (12) to fourteen (14) acres, more or less, and having according to a plat entitled "Property of Cecil F. Wynn" prepared by C. O. Riddle dated March 1970, reference being craved to said plat for exact metes and bounds.

This is that property conveyed to Mortgagor by deed of Patsy G. Quinn dated and filed concurrently herewith.

This is a second mortgage junior to that of L. Bruce Smith and Moise D. Smith as recorded in the RMC Office for Greenville County, South Carolina, in Mortgage Book 1637 at Page 93 and having a balance this date of \$67,795.31.

This mortgage is assumable with the consent of the Mortgagee.
