"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the south side of Valley Creek Drive, about 3 miles northwest of Greer, in Oneal Township, and being known and designated as Lot No. 28, Section 4 of Valleyhaven Acres, property of W. Dennis Smith as shown on plat prepared by John A. Simmons, Reg. Surveyor, dated July 15, 1960, and which plat has been recorded in the R.M.C. Office for Greenville County in Plat Book MM, Page 167. For a more particular description see the aforesaid plat.
