Words Used In This Document

- (A) Mortgage—This document, which is dated November 16, 1982, will be called the "Mortgage".
- (B) Mortgagor—Robert L. Daniel will sometimes be called "Mortgagor" and sometimes simply "I", "Me", "my", "mine", "myself", and "us" refer to the Mortgagor. R.M.C.
- (C) Lender—The South Carolina National Bank will be called "Lender" and sometimes simply "you", "Your" and "yours" refer to Lender. Lender is a national banking association which was formed and which exists under the laws of the United States of America.

- (D) Note—The note, note agreement, or loan agreement signed by Robert L. Daniel and dated Nov 16, 1982, will be called the "Note". The Note shows that I have promised to pay Lender

- (E) Property—The property that is described below in the section entitled "Description Of The Property" will be called the "Property".

My Transfer To You Of Rights In The Property

On this date, because you loaned me the money for which I gave you the Note, I mortgage, grant and convey the Property to you, your successors and assigns, subject to the terms of this Mortgage. This means that by signing this Mortgage, I am giving you those rights that are stated in this Mortgage and also those rights that the law gives to lenders who hold mortgages on real property. I am giving you these rights to protect you from possible losses that might result if I fail to:

- (A) Pay all the amounts that I owe you as stated in the Note and any future advances made under Paragraph 17 of this Mortgage.
- (B) Pay, with interest or finance charges, any amounts that you spend under this Mortgage to protect the value of the Property and your rights in the Property.
- (C) Keep all of my other promises and agreements under the Note and or this Mortgage.

This Mortgage secures any renewals, extensions, and or modifications of the Note.

Description Of The Property

- (A) The Property which I mortgage, grant, and convey to you, your successors and assigns, is located in Greenville County and has the following legal description:

ALL that certain piece, parcel or lot of land located in the County of Greenville, South Carolina, including all buildings and improvements thereon, being known and designated as Lot 97 on plat entitled "Heritage Lakes Subdivision" made by Heaner Engineering Co. Inc., as revised October 26, 1977, and recorded in the R.M.C. Office for Greenville County in Plat Book 621 at page 21, reference to same being herewith made for a more particular description.

This being the same property conveyed to Robert L. Daniel and Gail T. Daniel by deed of Frank P. Hammon, recorded in the Greenville County R.M.C. Office in Deed Book 1086 at page 530, and the said Gail T. Daniel having conveyed her one-half interest to Robert L. Daniel by deed of even date.

The Property also includes the following:

- (B) All buildings and other improvements that are located on the property described in paragraph (A) of this section;
