ALL that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, in the City of Simpsonville, on the southern side of Georgia Road, being shown and designated as Lot No. 6 on plat of SIMPSONVILLE ACRES, made by J. C. Hill, dated May 12, 1958, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "KK", at page 159, reference to which is hereby made for a more complete description by metes and bounds.
