RELEASE OF MORTGAGE LIEN

KNOW ALL MEN BY THESE PRESENTS, that for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, QOK Associates, A South Carolina General Partnership, the owner and holder of the Mortgage hereinafter referred to, and the Note secured thereby, does, subject to the conditions hereinafter stated, hereby release from the lien of that certain Mortgage from ROTHCON, A South Carolina General Partnership to QOK Associates, A South Carolina General Partnership, dated March 4, 1982 and recorded in Book 1565, at page 408, R.M.C. Office of Greenville County, South Carolina, the following described property, to wit:

Beginning at an iron pin on the Southern side of Saluda Lake Road and running thence with Saluda Lake Road N. 89-56 E. 95.10 feet to an iron pin, thence along the line of property of First Federal of South Carolina S. 38-00 E. 207.91 feet to an iron pin, thence along the line of property of John Conits S. 38-02 E. 155.44 feet to an iron pin, thence along the line of property of Ingles Market, Inc. S. 57-29 W. 171.00 feet to an iron pin, thence along the following lines of adjoining property of the grantor N. 32-31 W. 81.00 feet to an iron pin, thence N. 57-29 E. 87.79 feet to an iron pin, thence N. 38-00 W. 333.24 feet to an iron pin, the point of beginning.

PROVIDED, HOWEVER, that the security of QOK Associates, A South Carolina General Partnership, as described in the aforesaid Mortgage shall in all respects, except as to the premises hereinbefore described, be preserved and protected, and that the lien of said Mortgage except as hereby released and discharged, shall remain in full force and effect, and the terms, conditions, and covenants thereof, and the Note secured thereby, shall remain unchanged.
