"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot 32 on plat of Abney Mills, Poinsett Plant, which plat is recorded in the RMC Office for Greenville County in Plat Book QQ, at page 51, and having such courses and distances as will appear by reference to said plat.
