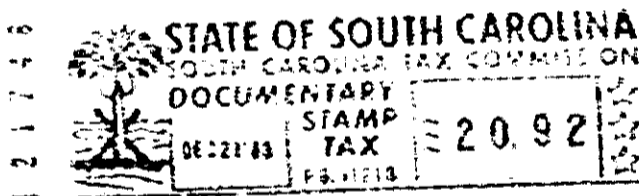
THIS MORTGAGE is made this 21st day of December, 1983, between the Mortgagor, Chalmers G. Bruce and Joleen B. Bruce, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Fifty Two Thousand, Two Hundred, Fifty and no/100ths Dollars, which indebtedness is evidenced by Borrower's note dated December 21, 1983, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on January 1, 2014.

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina.

ALL that lot of land in the State of South Carolina, County of Greenville, being shown and designated as Lot 1 on plat of ALTAMONT VILLAGE, SECTION ONE, prepared by Freeland & Associates, Surveyors, dated January 8, 1979, recorded in Plat Book 6-H at page 96 and having such metes and bounds as appear by reference to said plat. Said lot is located at the westerly intersection of Timber Lane and Tryon Avenue.

THIS is the identical property conveyed to the Mortgagors by deed of B. Phil Gillespie and H. Howell Clyborne, Jr., to be recorded of even date herewith.
