

THIS MORTGAGE made this 13th / day of January 19 84 among SHARON KAY MOON CHARMAN A/K/A Sharon charmafter referred to as Mortgagor) and FIRST UNION MORTGAGE CORPORATION, a North Carolina corporation (hereinafter referred to as Mortgagee):
WITNESSETH THAT, WHEREAS, Mortgagor is indebted to Mortgagee for money loaned for which Mortgagor has executed and delivered to Mortgagee a Note of even date herewith in the principal sum of and no/100 and no/100 bollars (\$ 18,000.00), with interest thereon, providing for monthly installments of principal and interest
beginning on the 15th day of February , 19 84 and
beginning on the root and interest are fully paid.
continuing on theday of each month thereafter until the principal and interest are fully paid;
AND WHEREAS, to induce the making of said loan, Mortgagor has agreed to secure said debt and interest thereon (together with any future advances) and to secure the performance of the undertakings prescribed in the Note and this Mortgage by the conveyance of the premises hereinafter described:
NOW, THEREFORE, in consideration of the aforesaid loand and the sum of Three Dollars (\$3.00) cash in hand paid to Mortgagor, the receipt of which is hereby acknowledged, Mortgagor hereby grants, sells, conveys, assigns and releases to Mortgagee, its successors and assigns, the following described premises located in <u>Greenville</u> County, South Carolina:
All that piece, parcel or lot of land in Gantt Township, Greenville

County, State of South Carolina containing .83 of an acre and described as follows:

BEGINNING at an old nail at a point on South Fairfield Road at the corner of Childress' land: Thence running N. 32-30 E. 148.8 feet to an iron pin; thence running N. 39-55 E. 70.5 feet to an iron pin; thence running S. 54-06 E. 187.3 feet to an iron pin; thence running S. 26-38 W. 116.7 feet to an iron pin; thence running S. 26-38 W. 22 feet to an iron pin at the road; thence running along the road, N. 75-90 W. 221.6 feet to the point of beginning.

Together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD the same with all privileges and appurtenances thereunto belonging to Mortgagee, its successors and assigns, forever, for the purposes hereinafter set out and Mortgagor covenants with Mortgagee, its successors and assigns, that Mortgagor is seized of, and has the right to convey, the premises in fee simple; that the premises are free and clear of all encumbrances except for a prior mortgage, if any; and that Mortgagor will warrant and defend title to the premises against the lawful claims of all persons whomsoever.

MORTGAGOR COVENANTS with Mortgagee, its heirs, successors and assigns as follows:

- 1. NOTE PAYMENTS. Mortgagor shall make timely payments of principal and interest on the above-mentioned Note and all payments required by any note(s) secured by lien(s) having priority over Mortgagee's within described lien or by any prior mortgage(s) in the amounts, in the manner and at the places set forth therein. This Mortgage secures payment of said Note according to its terms, which are incorporated herein by reference.
- 2. TAXES. Mortgagor will pay all taxes, assessments, water and sewer charges, and other governmental or municipal charges, fines, or impositions, for which provision has not been made hereinbefore, and will promptly deliver the official receipts thereof to the Mortgagee upon demand; and in default thereof the Mortgagee may pay the same and add the amount of such payment(s) to the principal indebtedness due Mortgagee, and the same shall be repaid by Mortgagor with interest at the then prevailing note rate upon demand. 4.00
