THIS MORTGAGE is made this 20th day of JANUARY, 19 84  
between the Mortgagor REECE ALBRIGHT ROBERTSON, JR.  
(herein "Borrower"), and the Mortgagee, THE SOUTH CAROLINA NATIONAL BANK,  
a corporation organized and existing under the laws of the United States of America,  
whose address is 101 Greystone Boulevard, Columbia, S. C. 29226  
(herein "Lender").
