To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding at any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville

All that certain piec, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, in the Paris Section, being known and as Lincoln Town as shown by plat thereof prepared by Dalton & Neves, dated June, 1945, and recorded in the R.M.C. Office for Greenville County in Plat Book S at Page 39. According to said plat, this lot fronts 140 feet on the eastern side of Gandy Avenue with a depth of 150 feet on both sides, with 140 feet across the rear. This property being known as Lot 134.

Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.
