THIS MORTGAGE is made this 1st day of December, 1983, between the Mortgagor, Rena C. Randolph

, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of \$17,377.55 (Seventeen Thousand Three Hundred Seventy Seven and 55/100) Dollars, which indebtedness is evidenced by Borrower's note dated December 1, 1983, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on December 30, 1990.....;

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of GREENVILLE, State of South Carolina.

All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, Greenville County, State of South Carolina, being shown as lot No. 4 and 17 feet of lot 3 of Block H of Hyland Terrace recorded in Plat Book K at pages 120-122 in the R. M. C. Office for Greenville County, and having according to a more recent survey made by R. B. Bruce dated December 15, 1959, the following metes and bounds, to-wit;

BEGINNING at an iron pin on the western side of Townes Street Extension at the joint front corner of lots 4 and 5 and running thence with the line of said lots N. 73-16 W., 150 feet to an iron pin; thence N. 16-44 E., 67 feet to an iron pin; thence S. 73-16 E., 150 feet to an iron pin on the western side of Townes Street Extension; thence with Townes Street Extension, S. 16-44 W., 67 feet to the point of beginning.
