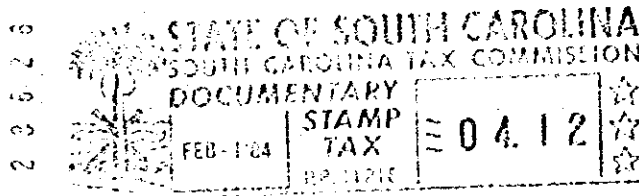
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is her-by acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 207 as shown on a plat entitled "Colonial Company Tract" recorded in the RMC office for Greenville County in Plat Book G, Pages 112 and 113 and having such metes and bounds as shown thereon, reference to said plat being made for a more complete description.

DERIVATION: This being the same property conveyed to Mortgagor herein by deed of Jonathan D. Schweigert and Deborah A. Schweigert as recorded in the RMC Office for Greenville County, South Carolina, in Deed Book 1207 Page 71, on January 10, 1984.

This mortgage is junior and second in lien to that certain note and mortgage given to NCNB Mortgage Corporation, as recorded in the RMC Office for Greenville County, South Carolina, in Mortgage Book 1484, Page 986, on October 19, 1979.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
