MORTGAGE

THIS MORTGAGE is made this 23rd day of FEBRUARY, 1984, between the Mortgagor, WILLIAM M. BOWEN, JR., AND JUNE B. BOWEN, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

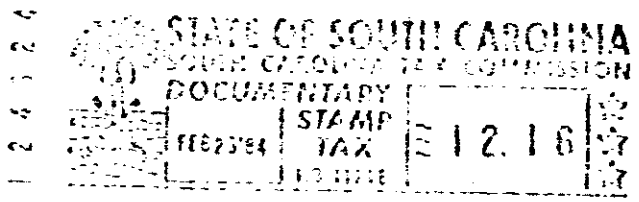
WHEREAS, Borrower is indebted to Lender in the principal sum of THIRTY-THOUSAND FOUR HUNDRED AND NO/100 Dollars, which indebtedness is evidenced by Borrower's note dated FEBRUARY 23, 1984, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on MARCH 1, 1999.....;

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of GREENVILLE, State of South Carolina.

ALL that certain piece, parcel or lot of land, situate, lying and being in the City of Simpsonville, County of Greenville, State of South Carolina and being shown and designated as Lot No. 7 on a plat of Bellingham, Section One, recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book "4-N" at Page 22, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on Abbotsford Drive at the joint front corner of Lots Nos. 6 and 7 and running thence with said common line N. 82-48 W. 150 feet to a point; thence running N. 7-12 E. 80 feet to a point; thence running S. 82-48 E. 150 feet to a point; thence running with Abbotsford Drive S. 7-12 W. 80 feet to the point of beginning.
