"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing .837 acres in accordance with plat made from Mary Sims dated June 18, 1981 by T.H. Walker, Jr., RLS, and being more fully described in accordance with said plat, to-wit:

BEGINNING at an iron pin on the western side of US Highway No. 25 right-of-way, joint corner with property now or formerly owned by Paul R. Tomlinson, Jr., and running thence along Tomlinson property line N 50-59 E, 208.2 feet to an iron pin; thence S 30-24 E, 177 feet to an iron pin; thence S 50-59 W, 208.2 feet to an iron pin on the western side of the right-of-way of US Highway No. 25; thence along said right-of-way, N 30-24 W, 177 feet to an iron pin, the point of beginning.
