1984, between the Mortgagor, Academy Rental Co., Inc.

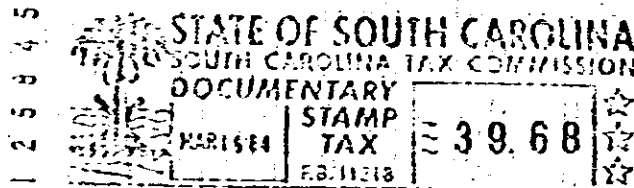
