THIS MORTGAGE is made this 24th day of February, 1984, between the Mortgagor, Phillip Riding and Beryl J. Riding, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as the major portion of Lot 4 on plat of Homestead Acres, Section 2, recorded in Plat Book 6H t page 77 and also as Property of Phillip Riding and Beryl J. Riding, recorded in Plat Book 10-H at page 99 and having such courses and distances as will appear by reference to the latter plat.

Being the same property conveyed by Premier Investment Co., Inc., by deed recorded herewith.

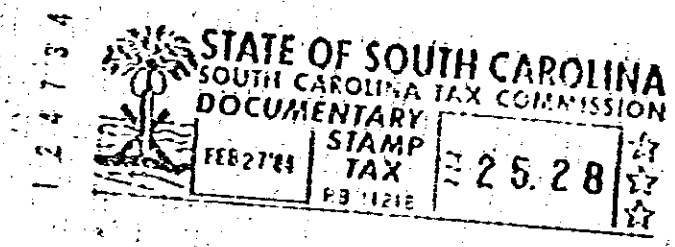
