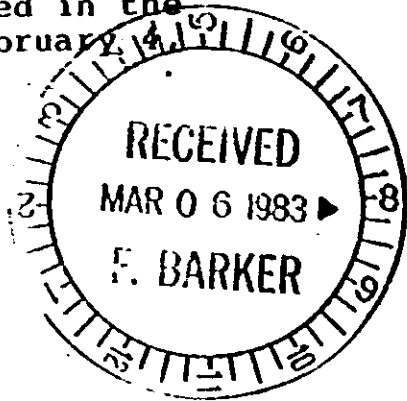
FOR VALUE RECEIVED, First Federal Savings and Loan
