We, J. C. Fowler and Hazel W. Fowler

SEND GREETING:

WHEREAS, we the said J. C. Fowler and Hazel W. Fowler

in and by our certain promissory note in writing of even date with these Presents, are well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of **Eighteen Thousand and No/100** - - - - - (\$ 18,000.00) Dollars, with interest from the date hereof at the rate of **thirteen** per cent (13 %) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of **Two Hundred Sixty Eight and 76/100** - -

C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to us the said mortgagor^s in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, located **about one mile South of Gowensville, on the East side of Goodjoin Road and being shown on plat of property made for J. C. & Hazel W. Fowler by S. D. Atkins, 4-25-73 and recorded in plat book 5 C page 75, Greenville County R. M. C. Office and having the following courses and distances, to wits:**

Beginning at a nail in center of road, corner of Campbell and running thence S. 79-15 E., 42 feet to pin on the bank of road, thence on the same course for a total distance of 230 feet; thence still with Campbell, N. 6-20 E., 334 feet to pin on line of Joe Dean Smith; thence with Smith, N. 84 E., 639 feet to old pin; thence with Smith S. 11-35 E., 755 feet to pin; thence still with Smith S. 49-40 W., 573 feet to center of said road (Pin set back 42 feet on bank); thence with center of said road, N. 48-10 W., 550 feet to nail; thence N. 36-30 W., 150 feet to nail; thence N. 23 W., 294 feet along road to the beginning corner and containing 16.1 acres, more or less.
