MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS,

Ted C. Russell

(hereinafter referred to as Mortgagor) is well and truly indebted unto Associates Financial Services Company of South Carolina, Inc.

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of FORTY -FOUR THOUSAND FOUR TWENTY-FOUR AND 84/100ths Dollars (\$ 44,424.84) due and payable

ACCORDING TO TERMS SET OUT IN SAID NOTE
(TOTAL AMOUNT ADVANCED \$23,998.65)

with interest thereon from this date at the rate of 19% per centum per annum, to be paid: monthly

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Mauldin, being known and designated as Lot No. 89 of a plat of "Addition to Knollwood Heights" of record in the RMC Office for Greenville County in Plat Book 4-F at Page 17 and having, according to said plat, such metes and bounds as are more fully shown thereon.

This being the same property conveyed to mortgagor herein and Jackie M. Russell by deed of Leon Hickman and Edna Lee Hickman dated and recorded November 4, 1977, in Book 1067 at Page 977. Jackie M. Russell conveyed her one-half interest in said property to Ted C. Russell by deed dated November 30, 1979, in Book 1118 at Page 260 of January 2, 1980.

This mortgage being junior to that certain mortgage given to First Federal Savings and Loan Association dated and recorded November 4, 1977, in Book 1414 at Page 982 in the amount of \$37,600.00.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
