"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southerly side of Carolina Street, and having, according to the plat of Webb Surveying and Mapping Co., the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Carolina Street and running thence S. 05-03 W. 317.72 feet to an iron pin; thence N. 85-56 W. 280.97 feet to an iron pin; thence N. 07-41 E. 314.95 feet to an iron pin on the southerly side of Carolina Street; thence S. 86-39 E. 266.55 feet to an iron pin, the point of beginning, and containing 1.985 acres, more or less.
