MORTGAGE OF REAL ESTATE

ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, Scott Renovations, Inc., a corporation organized and existing under the laws of the State of South Carolina. (hereinafter referred to as Mortgagor) is well and truly indebted unto Community Bank

ALL that piece, parcel or lot of land, with all buildings and improvements, situate, lying and being on the northwestern side of White Horse Road, known as 3406 White Horse Road, lying 189.4 feet, more or less, east of the north-eastern intersection of East Welcome Avenue with White Horse Road, and being shown and designated on a plat entitled "Property of Cobb Builders, Inc.", made by Carolina Surveying Company, dated May 23, 1979, recorded in the RMC Office for Greenville County, S.
