"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known as Lot No. 4 of Block S according to plat of property of J. P. Stevens and Co., Inc., entitled Slater Plant, Slater, S. C., made by Pickell and Pickell on October 28, 1955, and recorded in the RMC Office for Greenville County in Plat Book JJ at Page 105 and having such metes and bounds as shown thereon, reference to said plat being made for a more complete description.
