TO ALL WHOM THESE PRESENTS MAY CONCERN:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Paris Mountain Township, and being known and designated as Lot No. 26 of Rockview Heights as shown on plat recorded in the R.M.C. Office for Greenville County in Plat Book "AA" at Page 179 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on North Rockview Drive and running thence with the line of Lot No. 27, S. 38-30 E. 166.6 feet to an iron pin; thence N. 55-30 E. 100 feet to an iron pin; thence with the line of Lot No. 23, N. 38-30 W. 167 feet to an iron pin on North Rockview Drive; thence with North Rockview Drive, S. 55-30 W. 100 feet to an iron pin, the beginning corner.
