"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Part of Lot No. 55 according to plat of Cherokee Park, recorded in the RMC Office for Greenville County in Plat Book C, Page 96, reference to said plat being made for a more complete description.

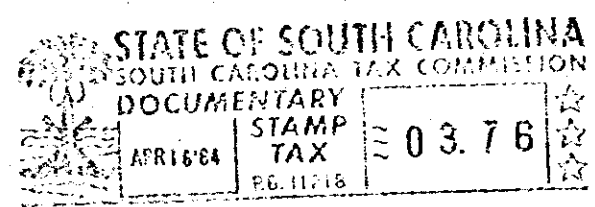
