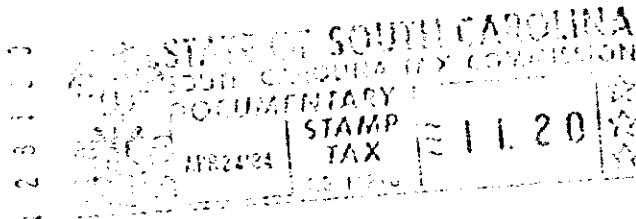
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, known and designated as Lot #4 in Cardinal Park, in accordance with plat recorded in Plat Book W, Page 27, R.M.C. Office for Greenville County, and being more fully described in accordance with said plat, to-wit:

BEGINNING at an iron pin on the South side of Lee Road, joint corner with Lot #5, and running thence along Lot #5, S. 16-35 E. 181.4 feet to an iron pin; thence S. 68-0 W. 70.3 feet to the corner of Lot #3; thence along Lot #3, N. 16-35 W. 181.1 feet to an iron pin on the South side of Lee Road; thence along Lee Road, N. 73-25 E. 70 feet to the point of beginning.
